#### Job Summary

To be sustainable, healthcare must deliver the highest possible value to patients from a radically reduced resource input. Aligning closely with NHS priorities on prevention, improved outcomes, patient experience and cost saving, sustainable healthcare is distinguished by its level of ambition – calling for rapid, transformative change.

The placements in Sustainable Dentistry are roles open to **current GDC registrants** nationally, with educational supervision provided through the Centre for Sustainable Healthcare (CSH) in Oxford. The successful candidates, known as scholars, will be supported to identify and undertake relevant projects which promote the sustainable use of resources in the provision of high quality dental care.

The scholars will build on the success of the highly acclaimed Sustainable Specialties Programme, pioneered by CSH first in kidney care and subsequently in mental health. In 2015 the first Sustainable Dentistry scholarships were launched by the former Kent, Surrey and Sussex (KSS) deanery with CSH. Following the success of the scholarship programme, Health Education England and the Centre for Sustainable Healthcare are pleased to announce the placements for 2017-18. The dental scholars will be supported alongside scholars on similar programmes in other specialties, and will have access to a study budget.

#### Location

The posts are open to dentists registered with the GDC currently working in the NHS in England. Base locations are available in London, Thames Valley, Kent, Surrey and Sussex. Scholars will be expected to engage with dental teams and to travel to relevant meetings in these regions.

#### Governance

The scholars will be hosted and managed by the Centre for Sustainable Healthcare. Scholars will continue to be employed by the NHS for the duration of their placement. Regular training meetings will take place with the Training Programme Director, through which appraisals will take place.

#### Level of responsibility

Under guidance from CSH, the scholars will contribute to the selection and design of projects undertaken. Once projects are agreed, the scholars will have responsibility for managing their own work, supported by

monthly meetings (in person or by telephone) with the Clinical Supervisor at the Centre for Sustainable Healthcare.

#### Training

The post will begin with a two-day induction course, during which the scholars will be briefed on sustainability in healthcare by CSH staff and will be directed to relevant resources.

The programme will also allow for attendance at relevant training events or conferences, supported by a study budget. The training programme will be overseen by the Training Programme Director for Dental Public Health (KSS).

#### Employment

Successful candidates in existing employment can retain employment or alternatively host employment arrangements can be provided.

#### Secondment

Candidates currently in StR training should seek permission from their Training Programme Director or Dean to seek agreement for an out/ in programme placement, subject to satisfactory completion of ARCP.

#### Benefits to career progression

The placements are a prestigious appointment and provide a unique opportunity to develop highly transferable skills in clinical leadership and quality improvement, while gaining a detailed understanding of environmental, social and economic sustainability of healthcare – a paradigm central to the future of dentistry. Scholars will present, where possible, at suitable events and conferences relevant to their current projects. Scholars will also receive support in submitting work for publication in peer-reviewed journals.

#### The Centre for Sustainable Healthcare (CSH)

CSH, an independent charity, is one of the foremost institutions in the world working on sustainable healthcare in research and practice. The Centre for Sustainable Healthcare (CSH) has pioneered and is respected nationally for a specialty-led approach combining research with support for local change, underpinned by wider engagement with patients and relevant industry and clinical bodies.

Based in Oxford, CSH currently manages the Royal College of Psychiatrists Sustainability Scholars programme, provides educational supervision to postgraduate medical trainees in the South West and the Thames Valley, and coordinates the national Sustainable Healthcare Education Network.
